Joining the Movement to Change Health Care

Patient Centered Medical Home

A national movement to fundamentally change the way primary health care is delivered has been growing in the last couple of years. Joining that movement, Marin Community Clinics is creating a Patient Centered Medical Home (PCMH). In a Patient Centered Medical Home, the focus is on patient access and self-management, chronic disease management, and team care. This approach relies on establishing "care teams" of proactive health care providers and other staff members who engage with the patient to maintain or improve health.

The timing is ideal for us now, as we have recently implemented electronic health records, and other technology that allows for patients to be reminded of recommended preventive care, along with follow-up care for those with chronic problems. This will result in a larger number of patients receiving routine cancer screenings, for example, rather than waiting for a patient to come for a doctor visit and then be referred for screening.

According to the highly-recognized health plan accrediting body National Committee for Quality Assurance, the Patient Centered Medical Home "is an innovative program for improving primary care. The program gives medical practices information about organizing care around patients, working in teams, and coordinating and tracking care over time." It facilitates stronger relationships between patients and their personal physicians, and when appropriate, the patient's family. It also utilizes technology to assure that patients receive

care when and where they need and want it, in a culturally and linguistically appropriate manner. As such, it is well-aligned with Marin Community Clinics' mission to improve the health of our patients and community by providing high quality, cost-effective, culturally sensitive, patientcentered health care.

In order to support community health centers like ours, the federal government has made funding available to undergo the changes necessary to become accredited Patient Centered Medical Homes. Marin Community Clinics is receiving funds from the Center for Medicare and Medicaid Innovation to participate in a three-year demonstration project designed to evaluate the effectiveness of the PCMH model in improving care, promoting health, and reducing the cost of care provided to Medicare beneficiaries. We have also received supplemental funding from the Health Resources & Services Administration which has resulted in improved patient access to nurse advice by telephone.

The staff has embraced the concept of care teams, and clinic leadership has used this new model as an opportunity to increase team-building activities among all levels of staff. We are all proud to be on the leading edge of the tremendous wave of change that is remaking the future of health care.
